<u>Nature of Position:</u> Employee(s) will be responsible for staffing fire, rescue, Basic Life Support ambulances, and marine equipment on a daily basis. Performs fire and rescue functions and provides emergency medical care. Responds to and mitigates emergencies. Employee must be able to perform the related duties with each function and complete annual skills evaluations.

**Responsibilities:** Complete daily checks of fire, rescue, EMS, and marine equipment. Complete light preventive maintenance and housekeeping duties. Individual assignments may include assisting with preplans, fire prevention, administrative functions, logistical support, and more assignments as determined by the Career Assistant Chief.

Employees must be able to work well in a team environment. Employees must pass a pre-employment physical and drug screen. Annual physical and substance abuse examinations will be required. There will be a three-month (90 day) probationary period for this position.

**Hours of Work:** 24 hours on, 72 hours off or as the Fire Chief deems necessary
